The undersigned, Managing Director and authorized representative of the Company desiring to amend and restate its Articles of Organization, hereby sets forth the following Amended and Restated Articles of Organization (these "Articles"):

ARTICLE I  
Name

The name of this company shall be: SHAMROCK PTC, LLC.

ARTICLE II  
Place of Business

The principal place of business and mailing address of this Company shall be 202 S. Rome Ave, Suite 150, Tampa, FL 33606, and such other place or places as may be designated by the manager from time to time.

ARTICLE III  
Registered Agent and Office

The initial registered agent for this Company shall be Providence Family Offices, LLC and the address of the registered agent for the service of process shall be 202 S. Rome Ave, Suite 150, Suite 150, Tampa FL 33606.

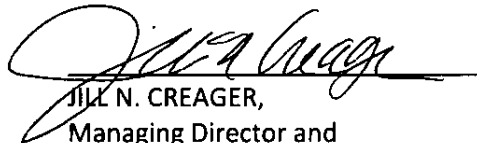
ARTICLE VII
