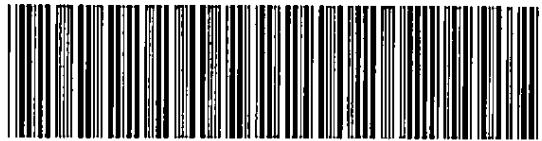



The effective date of dissolution is upon filing.


4. Pursuant to section 605.0701 (2), Florida Statutes, all the Members of the Company have voted to dissolve the Company on the date listed above.
