**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF

First: The Articles of Organization of Clear Investments LLC were filed with the Florida Secretary of State on March 21, 2014 and assigned Document Number L14000047479.

Second: Such Articles of Organization (the "Articles") are hereby deleted in their entirety and Amended and Restated as follows:

**ARTICLE I.
NAME**

The name of the limited liability company is Clear Investments LLC (the "Company").

**ARTICLE II.
MAILING AND STREET ADDRESS**
