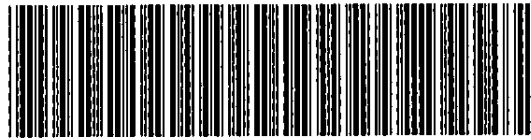

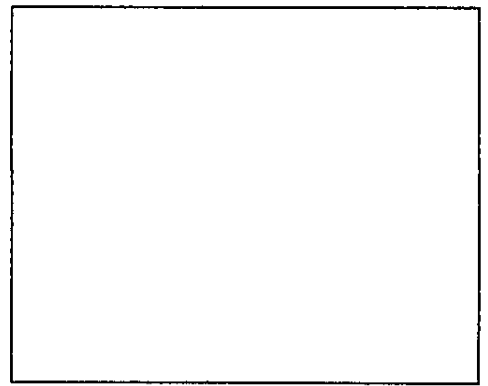



Operating Agreement




