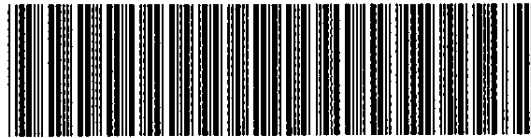

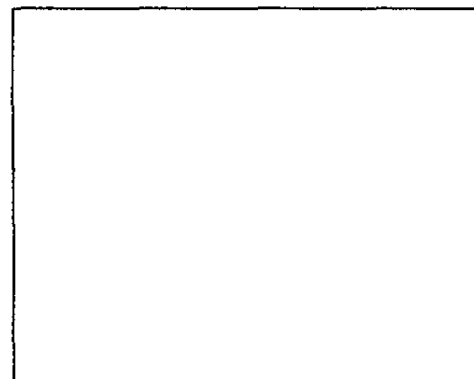

OF

Operating Agreement




