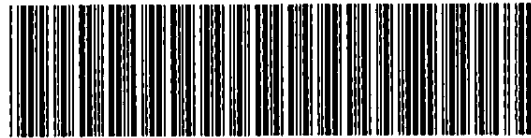

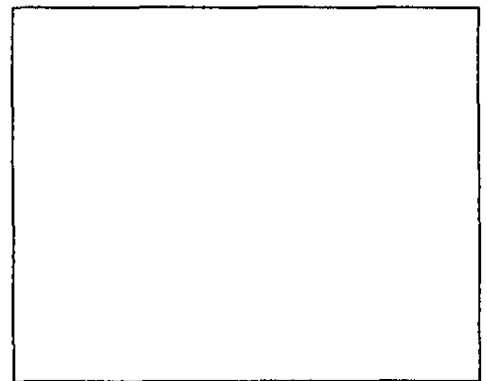



Operating Agreement


