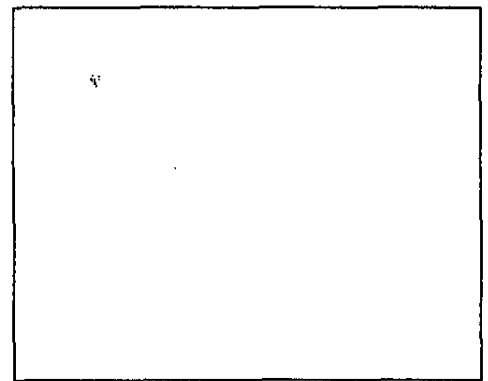



Operating Agreement




