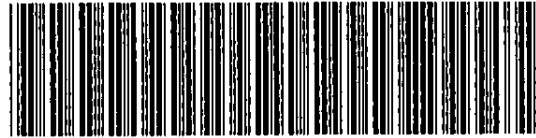

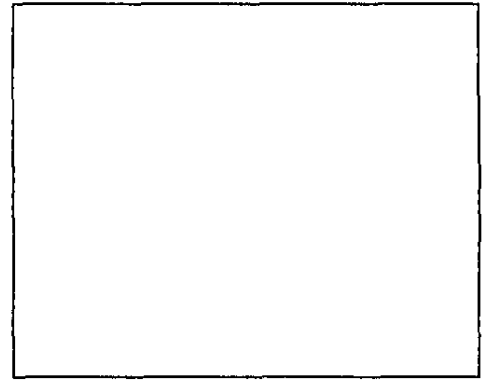

6. The plan of conversion has been approved in accordance with ss. 605.1041-605.1046.



Operating Agreement




