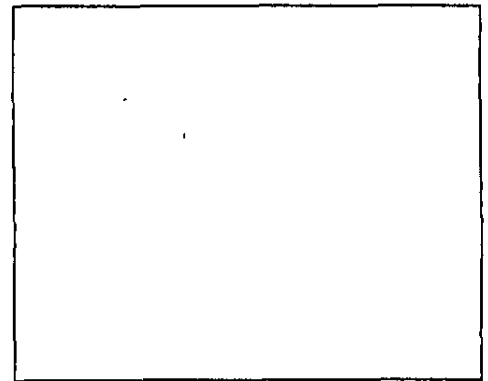



Operating Agreement




