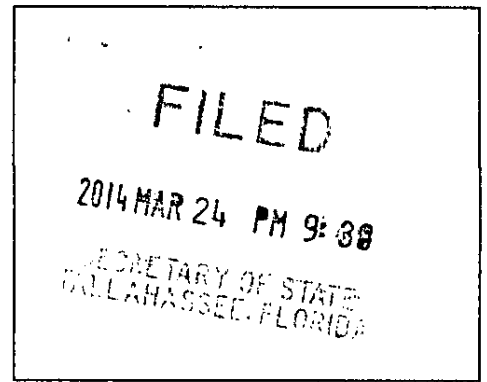

3. The name of the Florida Limited Liability Company as set forth in the attached Articles of Organization is: **YF Greenacres, LLC**



6. The plan of conversion has been approved in accordance with ss. 605.1041-605.1046.



Operating Agreement




