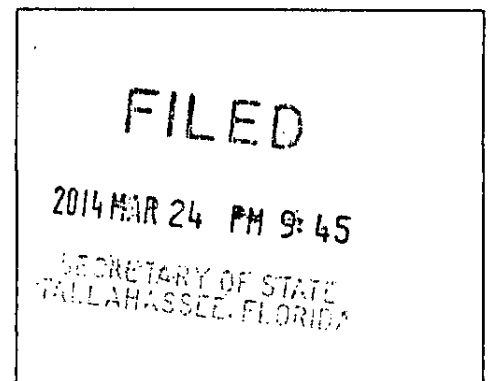

Operating Agreement




