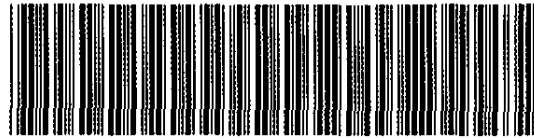

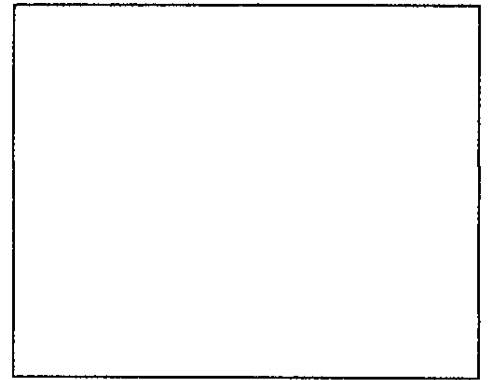



Operating Agreement




