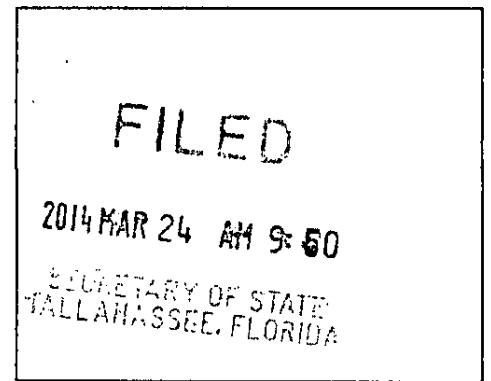

Operating Agreement




