**ARTICLES OF ORGANIZATION**

The undersigned authorized representative does hereby certify that the persons so identified herein have associated themselves together for the purpose of forming a limited liability company (the "**Company**") under the laws of the State of Florida.

**ARTICLE I**  
**NAME**

The name of the Company shall be: **veriMED Health Group Riverview, LLC**

**ARTICLE II**  
**ADDRESS OF BUSINESS**

The mailing and street address for the Company's principal office is: 26838 Tania Drive, Wesley Chapel, Florida 33544.

**ARTICLE III**  
**PERIOD OF DURATION**

The period of duration of the Company shall be indefinite.

**ARTICLE IV**  
**GENERAL POWERS**

The Company is formed for the purpose of conducting and undertaking, and shall have the power to conduct and undertake, any and all activities and actions authorized under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes.

**ARTICLE V**  
**MANAGEMENT**

All powers of the Company shall be exercised by or under the authority of the members and, except as otherwise provided in the operating agreement of the Company, if any ("**Operating Agreement**"), the business and affairs of the Company shall be managed by or under the direction of the members.

**ARTICLE VI  
RIGHT TO CONTINUE BUSINESS**

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of member or the occurrence of any other event which terminates the continued membership of member in the Company, the business of the Company shall not cease and the Company shall not be dissolved except by the unanimous consent of the remaining members or as otherwise provided in the Operating Agreement of the Company, if an Operating Agreement exists.

**ARTICLE VII  
RESTRICTIONS ON MEMBERSHIP**

New members shall be admitted to the Company by the unanimous consent of the remaining members or as otherwise provided in the Operating Agreement of the Company if such Operating Agreement exists. A member's interest in the Company may not be sold or otherwise transferred except with the unanimous consent of the members, or otherwise in accordance with the Company's Operating Agreement. Additional restrictions and conditions on membership may be set forth in the Operating Agreement or other agreements adopted by the members.

**ARTICLE VIII  
OPERATING AGREEMENT**

The members of the Company may adopt an operating agreement pertaining to the regulation, management, and other affairs of the Company (previously defined as the "Operating Agreement"), provided that such Operating Agreement shall not be inconsistent with these Articles of Organization or with the laws of the State of Florida. The Operating Agreement may be repealed or altered only in the manner now or hereafter prescribed therein, consistent with the laws of the State of Florida.

**ARTICLE IX  
INITIAL REGISTERED OFFICE AND AGENT**

The street address of the Company's initial registered office in Florida is 401 E. Jackson Street, Suite 1825, Tampa, Florida 33602, and the initial Registered Agent at such address is Tina Dunsford. The Company may change its registered office or its registered agent or both by filing with the Secretary of State of Florida a statement complying with Section 605.0114, Florida Statutes.

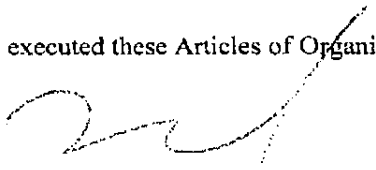
