## ARTICLES OF ORGANIZATION OF 750 CARICA ROAD, LLC

The undersigned, for the purpose of forming a limited inability company under the Florida Limited Liability Company Act, F.S. Chapter 605, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I -- NAME

The name of the limited liability company shall be 750 Carica Road, LLC ("Company").

#### ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the company shall be 229 North Collier Boulevard, Marco Island, FL 34145.

#### ARTICLE III -- DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual.

#### ARTICLE IV -- REGISTERED OFFICE AND AGENT
