**ARTICLES OF ORGANIZATION
OF
AGLOW MEDISPA OF NAPLES, PLLC,
A FLORIDA PROFESSIONAL LIMITED LIABILITY COMPANY**

The undersigned, for the purpose of forming a limited liability company under the Florida Professional Service Corporation and Limited Liability Company Act, Chapter 621, Florida Statutes, in accordance with the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I – NAME

The name of the limited liability company shall be Aglow MediSpa of Naples, PLLC, a Florida Professional Limited Liability Company (the "Company").

ARTICLE II – ADDRESS

The mailing and street address of the initial principal office of the Company shall be 311 Tamiami Trail, N., Naples, Florida 34102.

ARTICLE III – DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these Articles of Organization or in the Company's operating agreement (the "Operating Agreement").

ARTICLE IV – REGISTERED OFFICE AND AGENT

The name and street address of the initial registered agent of the Company in the State of Florida are Diane J. Brzezinski, 311 Tamiami Trail, N., Naples, Florida 34102.

ARTICLE V – ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the Company except with the unanimous prior written consent of all members and on such terms and conditions as shall be approved by unanimous consent of all members. All members of the Company must be licensed to practice medicine in the state of Florida. All members must be other professional limited liability companies, professional corporations, or individuals who themselves are duly licensed or otherwise legally authorized to render the same professional services as the Company.

ARTICLE VI – PURPOSE

The Company may engage in each and every aspect of the general practice of medicine and such other activities related to or incidental thereto, but only through its members, officers, employees, and agents who are duly licensed or otherwise legally authorized to render such professional services in the state of Florida.

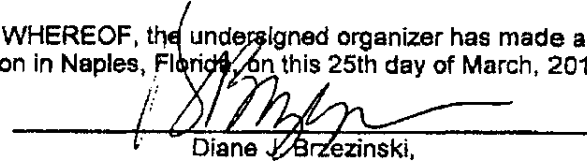
ARTICLE VII -- MANAGEMENT

The Company shall be managed by one or more Managers in accordance with the Operating Agreement adopted by the members for the management of the business and affairs of the Company. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these articles of organization. 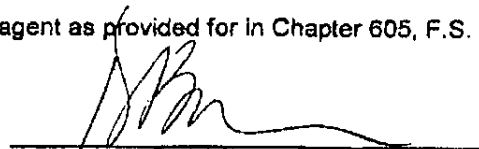
