

# PLAN OF MERGER OF LALP LOTS VI, LLC, WITH AND INTO LALP DEVELOPMENT, LLC

LALP Lots VI, LLC, a Florida manager-managed limited liability company, and LALP Development, LLC, a Florida manager-managed limited liability company, hereby adopt and approve the following plan as the Plan of Merger required by Section 605.1022, Florida Statutes. The terms of the Plan of Merger are as follows:

- 1. The names of the business entities planning to merge are LALP Lots VI, LLC, a Florida manager-managed limited liability company ("LALP Lots"), and LALP Development, LLC, a Florida manager-managed limited liability company ("Development"). As a result of the merger, LALP Lots shall be merged with and into Development. Development shall be the surviving business entity.
- 2. The merger shall be effective on the date the Articles of Merger are filed with the Department of State (the "Effective Date").
- 3. As a result of the merger, the sole membership interest in LALP Lots shall be cancelled. No change shall occur in the membership interest of Development.
- 4. The name and address of the Manager for LALP Lots is Vanguard Realtors, LLC, 7350 Point of Rocks Road, Sarasota, Florida 34242.
- 5. The name and address of the Manager for Development is Vanguard Realtors, LLC, 7350 Point of Rocks Road, Sarasota, Florida 34242.
- 6. This Plan of Merger shall be submitted to the Member and Manager of LALP Lots for approval. This plan shall be submitted to the Members and Manager of Development for approval.
- 7. The Members of Development having a membership interest in Development immediately prior to the Effective Date will hold the same membership interest, with identical designations, preferences, limitations, and relative rights, immediately after the merger.

- 8. The Member and Manager of LALP Lots and the Members and Manager of Development are hereby authorized to amend this plan at any time prior to the filing of the Articles of Merger, to the extent permitted by law.
  - 9. There are no other terms of or conditions to the merger.
