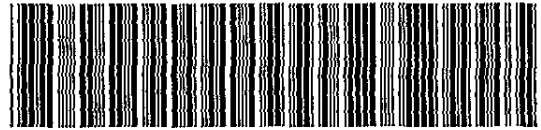

**FINAL JUDGMENT AGAINST DEFENDANTS AGOSTINHO MACEDO & MIRIAM DE LA  
C R P.A., AGOSTINHO MACEDO & MIRIAM DE LA C R, P.L.L.C., AND  
AGOSTINHO MACEDO & MIRIAM DE LA C R**

This matter came before the Court at a duly noticed hearing on August 13, 2014 on Plaintiffs' Motion for Final Default Judgment Against Defendants Agostinho Macedo & Miriam De La C R P.A., Agostinho Macedo & Miriam De La C R, P.L.L.C, and Agostinho Macedo & Miriam De La C R. The Court has reviewed the judicial default previously entered against the corporate defendants by Order dated July 23, 2014; has reviewed the Motion and Court file, including Plaintiffs' Verified Statements of Fact attached to the Complaint; has heard argument of counsel; and is otherwise advised in the premises. Based upon the record, it is hereby ORDERED and ADJUDGED as follows:

1. By Order dated July 23, 2014, the Court entered judicial defaults against Defendants Agostinho Macedo & Miriam De La C R P.A., Agostinho Macedo & Miriam De La C R, P.L.L.C, and

Agostinho Macedo & Miriam De La C R (collectively, the "Defendants"). Accordingly all well-pled allegations in the Complaint are deemed admitted.

2. The well-pled allegations in the Complaint establish that Plaintiffs, Agostinho Alfonso Macedo Moncayo and Miriam de la Concepcion Rodriguez Macedo (jointly, the "Plaintiffs"), are entitled to entry of a Final Judgment granting the Motion as provided herein. As such, Plaintiffs' Motion is hereby GRANTED.

3. The well-pled allegations in the Complaint have established:

a. As to Count I against Agostinho Macedo & Miriam De La C R P.A, the well-pled allegations in the Complaint establish that Agostinho Macedo & Miriam De La C R P.A was fraudulently formed on or about January 14, 2014 and assigned document number P14000004252 by the Florida Secretary of State. It has been established that Agostinho Macedo & Miriam De La C R P.A was formed, and may be operating a business using Plaintiffs' name and address without Plaintiffs' consent or knowledge.

b. As to Count II against Agostinho Macedo & Miriam De La C R P.L.L.C., the well-pled allegations in the Complaint establish that Agostinho Macedo & Miriam De La C R P.L.L.C. was fraudulently formed on or about March 24, 2014 and assigned document number L14000052095 by the Florida Secretary of State. It has been established that Agostinho Macedo & Miriam De La C R P.L.L.C. was formed, and may be operating a business using Plaintiffs' name and address without Plaintiffs' consent or knowledge.

c. As to Count III against Agostinho Macedo & Miriam De La C R, the well-pled allegations in the Complaint establish that Agostinho Macedo & Miriam De La C R was fraudulently formed on or about January 17, 2014 and assigned registration number G14000006295 by the Florida Secretary of State. It has been established that Agostinho Macedo & Miriam De La C R was formed,

and may be operating a business using Plaintiffs' name and address without Plaintiffs' consent or knowledge.

4. Based on the foregoing, Final Judgment is hereby entered in favor of Plaintiffs as follows:

a. Final Judgment is hereby entered in Plaintiffs' favor and against Defendant Agostinho Macedo & Miriam De La C R P.A as to Count I, and the Florida Department of State is hereby directed to immediately dissolve Agostinho Macedo & Miriam De La C R P.A., effective as of January 14, 2014, such that it ceases to exist or be recognized as a Florida entity.

b. Final Judgment is hereby entered in Plaintiffs' favor and against Defendant Agostinho Macedo & Miriam De La C R P.L.L.C as to Count II, and the Florida Department of State is hereby directed to immediately dissolve Agostinho Macedo & Miriam De La C R P.L.L.C., effective as of March 24, 2014, such that it ceases to exist or be recognized as a Florida entity.


c. Final Judgment in Plaintiffs' favor and against Defendant Agostinho Macedo & Miriam De La C R as to Count III, and the Florida Department of State is hereby directed to immediately dissolve Agostinho Macedo & Miriam De La C R, effective as of January 17, 2014, such that it ceases to exist or be recognized as a Florida entity.

d. Final Judgment is hereby entered in favor of Plaintiffs and against Defendants as to Counts IV, V, and VI. Defendants Agostinho Macedo & Miriam De La C R P.A., Agostinho Macedo & Miriam De La C R P.L.L.C., and Agostinho Macedo & Miriam De La C R are each permanently enjoined from using, publishing, printing, or displaying Plaintiffs' names and addresses in any manner.

5. The Court reserves jurisdiction to determine the amount of Plaintiffs' damages, including punitive damages, exemplary damages, and attorneys' fees pursuant to Florida Statutes,

Section 540.08, for which Defendants are liable. The Court also retains jurisdiction to enter further Orders as it deems appropriate or necessary to enforce the terms of this Final Judgment.
