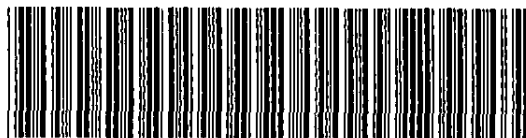

**ARTICLES OF ORGANIZATION  
OF FOUR P'S GROUP, LLC**

The undersigned, acting as an Authorized Member of this limited liability company pursuant to Chapter 605 of the Florida Statutes, hereby forms a limited liability company under the laws of the State of Florida and adopts the following Articles of Organization for said limited liability company:

**ARTICLE I - NAME OF LIMITED LIABILITY COMPANY**

The name of this limited liability company shall be Four P's Group, LLC.

**ARTICLE II - PERIOD OF DURATION**

The period of duration of this limited liability company shall commence on March 25, 2014, and shall continue until dissolved pursuant to Chapter 605 of the Florida Statutes.


