ARTICLES OF ORGANIZATION
OF
GENERATIONS DENTISTRY PLLC

1. Name. The name of this limited liability company is **GENERATIONS DENTISTRY PLLC** (the "Company"), and it shall be formed as a professional limited liability company under Chapter 621 of the laws of the State of Florida.

2. Duration. The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.

3. Purpose. The general nature of the business to be transacted by the Company is to engage in every phase and aspect of the business of rendering the same professional services to the public that a dentist, duly licensed under the laws of the State of Florida, is authorized to render, but such professional services shall be rendered only through members, officers, employees and agents of the Company who are duly licensed under the laws of the State of Florida to perform said services.

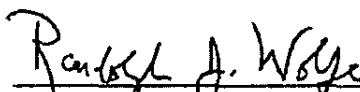
4. Place of Principal Office. The street address of the Company's principal office is 2401 West Kennedy Boulevard, Tampa, Florida 33609. The mailing address of the Company is 777 N. Ashley Drive, Unit 2708, Tampa, Florida 33602.

5. Registered Agent and Office. The name of the initial registered agent of the Company is F & L Corp. The street address of the initial registered agent of the Company is One Independent Drive, Suite 1300, Jacksonville, Florida 32202.

6. Management of the Company. The management of the Company shall be vested in the managers of the Company. The initial manager of the Company is David J. Goldschein, D.D.S., whose address is 777 N. Ashley Drive, Unit 2708, Tampa, Florida 33602.

7. Operating Agreement. The members shall have the power to adopt, alter, amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.
