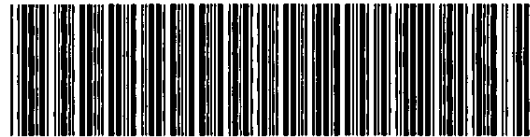

ARTICLES OF ORGANIZATION OF  
K&M ALL AMERICAS EXPORT, LLC

The undersigned, desiring to form a limited liability company under and pursuant to §605.0201, Florida Statutes, does hereby certify as follows:

FIRST: The name of said limited liability company shall be K&M All Americas Export, LLC.

SECOND: K&M All Americas Export, LLC shall exist in perpetuity.

THIRD: Copies of the Operating Agreement of K&M All Americas Export, LLC may be obtained from the Manager at 2421 San Domingo Street, Coral Gables, Florida 33134, which is the place in the State of Florida where the principal office of the limited liability company is located. 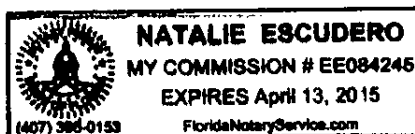

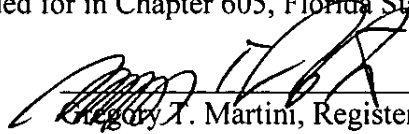
