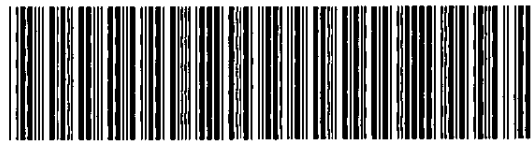




2. The name of the converted entity is **SAL-CRO, LLC**, which is a Florida limited liability company as set forth in the attached Articles Of Organization.

Article III. Initial Registered Agent and Address






