**ARTICLE I**

**NAME**

The name of the limited liability company is VA & JN INVESTMENT, LLC (the "Company").

**ARTICLE II**



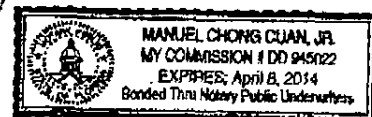


