

ARTICLES OF ORGANIZATION OF MVP H² GAINESVILLE - UNIVERSITY & 34TH RESTAURANT, LLC

- 1. Name. The name of this limited liability company is MVP H² Gainesville University & 34th Restaurant, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.
