The undersigned subscriber to these Articles of Organization, a natural person competent to contract, hereby forms a limited liability company under the provisions of Chapter 608 of the laws of the State of Florida.

## ARTICLE I

The name of the limited liability company is: RECON GREEN, LLC

#### **ARTICLE II**

The duration of this limited liability company shall be perpetual.

#### ARTICLE III

## ARTICLE VI

In the event of the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in this limited liability company, the business of the limited liability company may be continued if a majority of all of the remaining members consent to such continuance of business.

#### **ARTICLE VII**

This limited liability company is to be managed by a manager or managers and the name and address of the initial manager who is to serve as manager until the first annual meeting of members or until his successor or successors are elected and qualified.

#### ARTICLE IX

No debt shall be contracted nor liability incurred by or on behalf of this limited liability company except by all of its managers.

### **ARTICLE XIII**

The interest of a member in this limited liability company may be transferred or assigned as provided in any operating agreement; however, if all of the other members of this limited liability company other than the member proposing to dispose of his or its interest do not approve of the proposed transfer or assignment by unanimous written consent, the transferee of the interest of the member shall have no right to participate in the management of the business and affairs of this limited liability company or to become a member. Such transferee shall be entitled to receive only the share of profits or other compensation by way of income and the return of contributions to which that member otherwise would be entitled.
