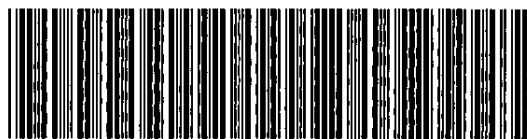

**ARTICLES OF ORGANIZATION
OF
MD EXPANSION 2, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Revised Act, Chapter 605, Florida Statutes hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be MD EXPANSION 2, LLC ("Company").

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the Company is 18550 U.S. Highway 441, Mount Dora, Florida 32757.

ARTICLE III - DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State or on another effective date as specified. The Company's existence shall be perpetual unless the company is dissolved earlier as provided in these Articles of Organization or in the Operating Agreement.

ARTICLE IV – REGISTERED AGENT AND OFFICE

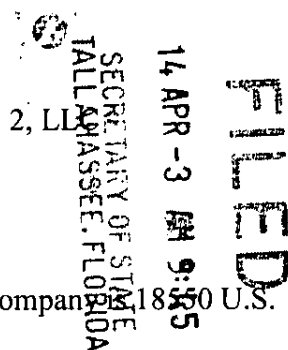

ARTICLE V – ADMISSION OF NEW MEMBERS

Except as set forth in the Operating Agreement, no additional members shall be admitted to the company except with the unanimous written consent of all the members of the Company and on such terms and conditions as shall be determined by all the members.

ARTICLE VI – MANAGEMENT

The Company shall be manager - managed by a manager in accordance with Operating Agreement adopted by the members for the management of the business and affairs of the Company. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization. Pursuant to Section 605.04074 2(a) of the Florida Revised Limited Company Act, a Member of the Company shall not be an agent of the Company solely by virtue of being a member, however, the Manager is an agent for the Company.

The undersigned affirms that the Company has at least one Member at the time these Articles become effective and the below Member is an authorized agent to sign the initial Articles of Organization.
