

RESTATEMENT OF ARTICLES OF ORGANIZATION OF THE LLC NOW TO BE KNOWN AS UNMANNED AERIAL SYSTEMS RESEARCH, LLC.

The Fictitious Name, Unmanned Aerial Systems Research, was initially established under the auspices of Destin International Book Fairs, LLC, for the purpose of using literary events as sUAS Drone educational or informational presentations.
