

ARTICLES OF ORGANIZATION

OF

BOMAR REALTY I, L.L.C.

The undersigned initial members of BOMAR REALTY I, L.L.C., a Florida limited liability company formed hereunder (the "Company"), hereby form a limited liability company under the laws of the State of Florida.

ARTICLE I. COMPANY NAME

ARTICLE VI. ADMISSION OF ADDITIONAL MEMBERS

ARTICLE VII. RIGHT OF ASSIGNEE TO BECOME A MEMBER
