ARTICLES OF ORGANIZATION

of

FIT MAMA LLC

(A Florida Limited Liability Company)

The undersigned, desiring to form a Limited Liability Company in the State of Florida pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, hereby certifies:

ARTICLE I - NAME

The name of the limited liability company shall be FIT MAMA LLC, hereinafter referred to as the "Company".

ARTICLE II - ADDRESS

The principal street address and mailing address of the Company is 4731 Glenn Pine Lane, Boynton Beach, Florida 33436.

ARTICLE III - PURPOSE

The Company is organized to conduct business for any and all lawful purposes under the laws of the State of Florida.

ARTICLE IV - MANAGEMENT

The Company shall be managed by one or more managers and is a manager-managed Company. The initial manager of the Company shall be Jennifer Neal. These Articles may be amended only as provided by law or in accordance with the Company's Operating Agreement.
