

The undersigned, desiring to form a limited liability company under and pursuant to §605.0201, Florida Statutes, does hereby certify as follows:

- FIRST: The name of said limited liability company shall be 3503 Wildwood, LLC.
- SECOND: 3503 Wildwood, LLC shall exist in perpetuity.
- THIRD: Copies of the Operating Agreement of 3503 Wildwood, LLC may be obtained from the Manager at 295 N. Coconut Lane, Miami Beach, Florida 33139, which is the place in the State of Florida where the principal office of the limited liability company is located. 
