



ARTICLES OF ORGANIZATION OF LFRC, LLC A FLORIDA LIMITED LIABILITY COMPANY



ARTICLE I NAME

The name of this Limited Liability Company shall be LFRC, LLC, and its principal place of business and mailing address shall be located at 8256 Lake Serene Drive, Orlando, Florida 32836. 32836.

ARTICLE II COMMENCEMENT OF EXISTENCE

This Company shall exist for a period of thirty (30) years commencing on the date of filing of these Articles of Organization with the Florida Secretary of State, unless sooner dissolved according to law.

ARTICLE III GENERAL PURPOSE; GENERAL POWERS

The general purpose of this Company shall be the transaction of any and all lawful business.
