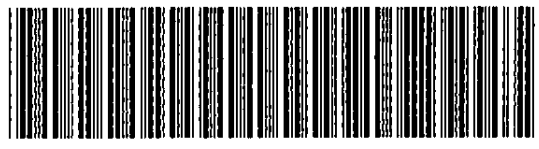

FOR FLORIDA
LIMITED LIABILITY COMPANY

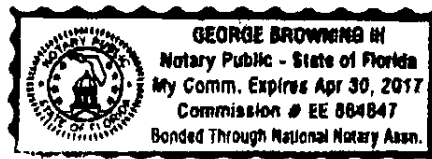
