

1. Name. The name of this limited liability company is **I GOT IT HOSTING, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

2. Duration. The Company's existence shall be effective as of April 2, 2014 and shall thereafter be perpetual.


