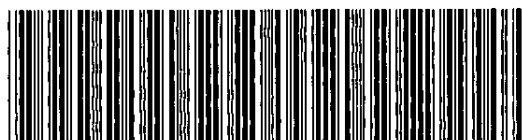

Principal Office

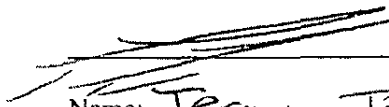
