The name of the limited liability company is: Rizzetta Technology Services, LLC.

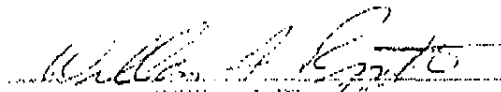
ARTICLE II. ADDRESS

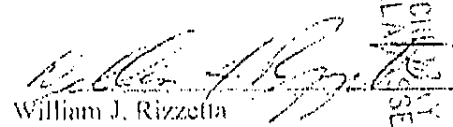
