The undersigned hereby submits these Articles of Organization (the "*Articles of Organization*") for purposes of forming C&H Motorsports, LLC, a Florida limited liability company, under the Florida Revised Limited Liability Company Act, Chapter 605, *Florida Statutes*.

ARTICLE I - Name

The name of the limited liability company formed pursuant to the filing of these Articles of Organization is C&H Motorsports, LLC, a Florida limited liability company (the "*Company*").

ARTICLE II - Address

The mailing and street address of the Company is 300 North Star Court, #320-322, Sanford, Florida 32771.

ARTICLE III - Duration

The period of duration for the Company shall be perpetual, unless dissolved by its membership or in accordance with the terms of an operating agreement, if any.
