SECOND AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
C&H MOTORSPORTS, LLC

The undersigned hereby submits these Second Amended and Restated Articles of Organization (these "*Second A/R Articles of Organization*") which amends and restates to the entirety the Amended and Restated Articles of Organization filed October 24, 2014 ("*Prior Articles of Organization*") of C & H Motorsports, LLC, a Florida limited liability company (the "*Company*"), and the same is submitted under the Florida Revised Limited Liability Company Act, Chapter 605, *Florida Statutes*, to be made effective as of the date of filing.

ARTICLE I - Name

The name of the Florida limited liability company, formed effective as of April 11, 2014, pursuant to the filing of the original articles of organization on such date, is C&H Motorsports, LLC.

ARTICLE II - Address

The mailing and street address of the Company is 897 Ronald Reagan Boulevard, Longwood, Florida, 32750.

ARTICLE III - Duration

The period of duration for the Company shall be perpetual, unless dissolved by its members in accordance with the terms of an operating agreement, if any.

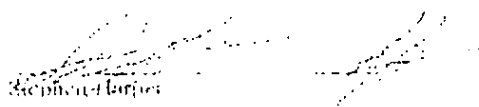
ARTICLE IV - Management

The Company shall be manager-managed. The name and address of the manager of the Company is Stephen Harper, 897 Ronald Reagan Boulevard, Longwood, Florida, 32750. The Manager shall have all authority to direct the business and operations of the Company except as specifically delegated by the Manager.

The sole officer and the President of the Company shall be Stephen Harper. The President of the Company shall be authorized to take such acts as may be required to manage and operate the day to day aspects of the Company's business. Except as provided in these Second A/R Articles of Organization or as otherwise agreed in writing by the Manager or in accordance with the terms of an operating agreement, if any, the Company shall have no officers.

ARTICLE V - Registered Agent
