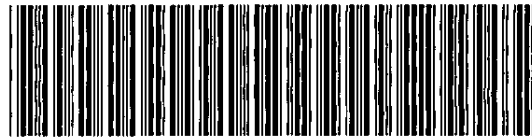

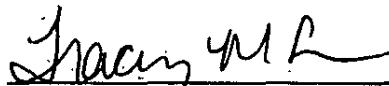
ARTICLE V - LIABILITY OF MEMBERS
