ARTICLES OF ORGANIZATION OF
SJP INVESTMENT PROPERTIES, LLC

The undersigned authorized representative of a member of a limited liability company pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, hereby submits the following Articles of Organization:


ARTICLE III. PURPOSE - The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.
