**ARTICLES OF ORGANIZATION
OF
SETAI 3509 LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, pursuant to Chapter 605 of the Florida Statutes (the "Act"), hereby makes, acknowledges and files the following Articles of Organization (the "Articles").

ARTICLE I. NAME

The name of the limited liability company is Setai 3509 LLC (the "Company").

ARTICLE II. MAILING AND STREET ADDRESS

The mailing address and street address of the principal office of the Company shall be 101 20th Street, Suite 3509, Miami Beach, Florida 33139.

ARTICLE III. REGISTERED AGENT AND OFFICE
