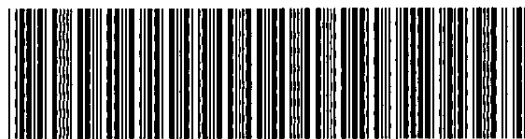

MANAGEMENT**

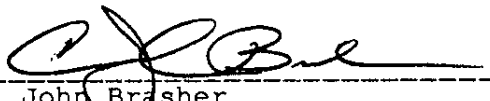
