**ARTICLES OF ORGANIZATION  
OF  
GENERAL SkyCAM, LLC**

The undersigned, desiring to form a limited liability company under and pursuant to Chapter 605 of the Florida Statutes, entitled the Florida Revised Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company.

**ARTICLE I  
NAME**

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is GENERAL SkyCAM, LLC.

**ARTICLE II  
ADDRESS**

The Company's street address of its principal place of business in Florida is 741 Forgotten Creek Lane, Pensacola, Florida 32514, and its mailing address is 741 Forgotten Creek Lane, Pensacola, Florida 32514, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the Manager.




