I recently attempted to create an LLC online. The desired name of the entity is SPG SYSTEMS, LLC, Document Number W14000023507. The tracking number is 500258962215.

I received an email today stating that I could not use the name SPG SYSTEMS, LLC because it was too similar to SPG SYSTEMS, INC. (Document Number P14000028740) which was dissolved on 04/13/2014.

I created SPG SYSTEMS, INC. and dissolved it before commencing business in favor of an LLC, which I also want to name SPG SYSTEMS. I have no intention of revoking the dissolution of SPG SYSTEMS, INC. If you check the agent name, officer name, and address of the LLC and the INC, you'll see they are the same.

I spoke with Barbara at your office today and she indicated that faxing you this letter would be sufficient to allow you to create SPG SYSTEMS, LLC and that it was not necessary to have it notarized.
