ARTICLES OF ORGANIZATION

1. **Name.** The name of the limited liability company is INSPECTOR HOMES, LLC.
2. **Purpose.** The purpose of this limited liability company is home inspections and may include the transaction of any and all lawful business for which limited liability companies may be organized in the state of Florida.

4. **Term.** Term of this LLC shall be perpetual.


