**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
ACE SALONS LLC**

First: The Articles of Organization of ACE Salons LLC were filed with the Florida Secretary of State on April 15, 2014 and assigned Document Number L14000062172.

Second: Such Articles of Organization (the "Articles") are hereby deleted in their entirety and Amended and Restated as follows:

**ARTICLE I.
NAME**

The name of the limited liability company is ACE Salons LLC (the "Company").

**ARTICLE II.
MAILING AND STREET ADDRESS**

The mailing address and street address of the principal office of the Company shall be 44 West Flagler Street, Suite 425, Miami, Florida 33130.

**ARTICLE III.
REGISTERED AGENT AND OFFICE**
