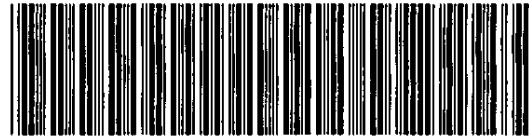



**ARTICLES OF ORGANIZATION
OF
KIDZ WORLD OF PLAY, LLC**

The undersigned hereby certifies that she is the subscriber who is forming a Limited Liability Company under Florida Statutes Chapter 608. The following Articles of Organization are hereby adopted.

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the Limited Liability Company shall be **Kidz World of Play, LLC**. The principal and mailing address of the Limited Liability Company shall be 10715 Plantation Bay Drive, Tampa, FL 33647.

ARTICLE II - DURATION; EFFECTIVE DATE


