ARTICLES OF ORGANIZATION

OF

1035 INVESTMENT GROUP, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, adopts the following Articles of Organization:

ARTICLE I

Name

The name of the Company is **1035 INVESTMENT GROUP, LLC** and its street address is 3800 Bird Road, Miami, Florida 33146.
