**ARTICLE II - PRINCIPAL OFFICE**

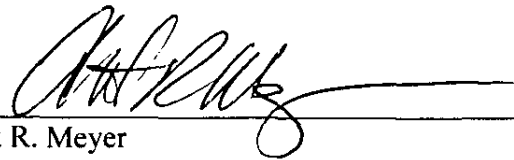
The street address, and the mailing address, of the principal office of the Company is 1906 Clint Moore Road, Suite 4, Boca Raton, FL 33496.

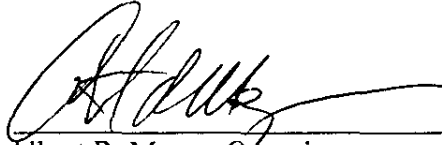
