ARTICLE I

The name of this limited liability company is:

NOOMA TECHINOLOGIES, LLC

ARTICLE II

ARTICLE III

This limited liability company has been organized for the purpose of conducting any and all lawful business or activity for which limited liability companies may be organized.

ARTICLE IV

The total number of units of ownership that the limited liability company shall have authority to issue is one thousand (1,000) Class A units.

1. The Class A ownership units shall have the following rights and characteristics:

(a) Each unit of Class A shall be entitled to one (1) vote in all matters upon which the members are entitled to vote. There shall be no cumulative voting.

(b) No holder of units of Class A shall have any preemptive rights to subscribe to or acquire (i) unissued or treasury units of the limited liability company, (ii) securities of the limited liability company convertible into or carrying a right to acquire or subscribe to units of any class or (iii)

any other obligations, warrants, rights to subscribe to shares or other securities of the limited liability company of any class, in each case whether now or hereafter authorized;

(c) Subject to the provisions of law, these articles of organization, and the operating agreement of the limited liability company, units of Class A shall participate in distributions declared by this limited liability company; and

(d) In the event of any liquidation, dissolution or winding up of the limited liability company, whether voluntary or involuntary, the holders of Class A units shall be entitled, after payment or provision for payment of the debts and other liabilities of the limited liability company and the amounts to which holders of any preferred units shall be entitled, to the remaining net assets of the limited liability company.

ARTICLE V

This limited liability company is managed by its Member(s). The specific duties, powers, and restrictions are set forth in the operating agreement of this limited liability company.
