#### ARTICLES OF ORGANIZATION OF EV KEY WEST, LLC

The undersigned subscriber to these Articles of Organization, a natural person competent to contract, does hereby form a limited liability company under the laws of the State of Florida.

#### ARTICLE I Name

The name of the limited liability company shall be EV KEY WEST, LLC.

# ARTICLE II Address and Place of Business

# ARTICLE III Period of Duration
